

PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS
CAUTION: Harmful if swallowed. Keep away from children, domestic animals and pets. Causes moderate eye irritation. Do not get in eyes or on clothing. User Safety Requirements

SELECTION OF TREATMENT AREAS

Determine areas where rats, mice, or meadow voles** will most likely find and consume the bait. Generally, these are along walls, by graweod openings, in corners and concealed places, between floors and walls, or in locations where rats, mice, or meadow voles** or their signs have been seen. Protect bait from rain and snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS

Each SureKill Brand Command Block weighs 1 oz.

RATS: Place 3 to 16 bait blocks (at intervals of 15 to 30 feet) per placement in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MOUSE AND MEADOW VOLES:** Place one block per placement. Space placements at 8 to 12 foot intervals. In infested areas, two blocks may be needed at points of very high activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse or meadow vole** activity cease.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Wearing gloves, collect and dispose of all dead exposed animals and leftover bait. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PESTICIDE STORAGE: Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

PESTICIDE DISPOSAL: Dispose of wastes resulting from the use of this product in trash or at an approved waste disposal facility.

CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container.
